

GS1 EPCglobal - Subscription Application

GS1 Australia is an authority on cross sector supply chain standards. Our standards and services, including identification, bar coding, business messaging, data synchronisation and radio frequency identification technology, are part of the global GS1 System.

GS1 Australia is the Australian contact point for subscription to GS1 EPCglobal, the assignment of EPC Manager Numbers, and advice and information on GS1 EPC standards and implementation through the GS1 EPCglobal community.

STEP 2 GS1 EPCglobal Australia Subscription

GS1 Australia Subscription Membership provides the right to subscribe to GS1 EPCglobal.

GS1 EPCglobal subscription covers subscriber access to the EPCglobal standards, and the ability to participate in standards development, information sharing and working/user groups. Participation in work groups may require execution of a separate Intellectual Property (IP) Agreement.

GS1 EPCglobal subscription does not include the registration of EPC Manager Numbers on the Object Name Service (ONS). Your GS1 Global Company Prefixes (GCPs) are automatically considered to be EPC Manager Numbers and can be registered on the ONS by completing a separate EPC Manager Number Request Form (available from the GS1 Australia website at www.gs1au.org/information_library/application_forms.asp).

STEP 3 GS1 EPCglobal Subscription Fees & Payment Methods

GS1 EPCglobal subscription is provided to subscriber members of GS1 Australia on an "opt in" basis and can be invoked at any time with a once off registration fee payment of \$60.00 (excluding 10% GST)
